Por medio de la presente informamos las condiciones de inscripción para el **South American Youth and Masters Championships - Santiago de Chile 2025** (Chile) para aquellos deportistas de las siguientes categorías:

Debido a la inmediatez del cierre de la inscripción preliminar con respecto a la realización de nuestra Final Nacional, no se realizará evaluatorio alguno para estas categorías, quedando en condiciones de participar del torneo como miembro de la Selección Nacional en condición de autofinanciados, los primeros seis (6) arqueros del ranking de selección de cada categoría, los primeros tres (3) como miembros titulares y los siguientes como suplentes. Si alguno de los titulares decide no participar, su lugar podrá ser ocupado por uno de los suplentes hasta completar los 3 cupos, respetando siempre el orden del ranking.

Para poder realizar las preinscripciones numerales, es necesario que aquellos que queden posicionados informen a más tardar el día 20 de diciembre su intención de participar para que no corran las multas por inscripciones tardías (la organización nos concedió una prórroga a la fecha indicada en la invitación).

El Ranking de Selección estará conformado por los arqueros participantes de la Final Nacional 2024 que sumen los puntajes de sus dos (2) mejores torneos disputados entre el 08/08/2024 y el 08/12/2024 (incluida la FN), según lo establece el Comunicado N° 051/23.

Los arqueros que participen de esta competencia en calidad de autofinanciados, tendrán los mismos deberes y obligaciones que cualquier delegación y estarán sujetos a lo que establezca el Comité Técnico para la misma, ya que más allá del origen de su financiación, serán parte de una representación oficial.

En la invitación que se adjunta al presente comunicado podrán encontrar los valores de inscripción, matrícula WA, alojamientos, traslados y comidas.

PRELIMINARY & FINAL REGISTRATION

All entries, accommodation reservations, transport needs, flight arrival/departure information and visa invitation letter requests are to be completed using the World Archery Online Registration System WAREOS <https://extranet.worldarchery.sport>. This system handles the entire registration process for this event. No entry forms, hotel reservations or transportation forms will be accepted; all information must be entered into WAREOS.

Member associations can login to WAREOS at <http://extranet.worldarchery.sport> with the username and password assigned by World Archery. After entering WAREOS, selecting the event from the list will allow a member association to register their athletes. Select/press the “Entries” button to see the list of categories in the event. Select/press the “category” to enter the athlete and official numbers/details participating for that event. A WAREOS User Manual can be downloaded in PDF format (English) upon login.

Contact wareos@archery.sport with any questions regarding **technical problems on WAREOS**. For any question regarding the organisation of the event (transport, accommodation, meals, invoices, visa etc.) please contact **directly the LOC**.

There is no limit in the number of archers a country can register in each category for the open event. Only four archers can be registered by a national federation for the South American Championship. A total of three

archers will be the minimum number required for an individual or team category to be valid for the medal count.

Member Associations can only use WAREOS to make any changes, amendments or cancellations to entries and will be able to do so at any time. An email will automatically notify the Organising Committee and Member Association of any changes made in WAREOS.

CLUB ARCHERS' PARTICIPATION

Other athletes (not competing as a country but only as a club) can register on Open WAREOS at <https://extranet.worldarchery.sport/> with their username and password if they have registered in the past or register for login details if this is the first time.

After creating the profile, follow the instructions to register for the event.

Please contact World Archery (wareos@archery.sport) if you have technical problems at WAREOS. For any questions regarding the organization of the event (transportation, lodging, meals, etc.), please contact the LOC directly.

Archers who register using Open WAREOS may compete only as individuals in the open event. They may not be part of teams or mixed teams. Only archers from South American countries registered on WAREOS (not in Open WAREOS) can compete in the South American Championship.

LUNCH

TRANSPORTATION

Local transport will be available between the official hotel, practice and competition venues for free. Transport timetables will be confirmed.

VISA

All participants who need an entry visa to Chile will be required to complete the **Visa Support sections** in WAREOS by no later than **17 January 2025**.

It is the applicants' responsibility to supply the necessary information, ensuring all details are up to date, correct and submitted by the deadlines specified.

In addition, all participants that require a visa are kindly requested to supply a copy of their latest/valid passport. Copies of each application can be uploaded on WAREOS. All passport copies and personal details entered/uploaded to WAREOS will be held securely and in the strictest of confidence and not shared with other parties.

Introduction

The Member Association acknowledges to have understood and accepted in their whole and without any restrictions the sale and purchase terms and conditions of this invitation package, and of the registration platform <https://extranet.worldarchery.sport/wareos/>.

Consequently, the Member Association who wishes to register to an event, and book some or all associated extras proposed by the local organizing committee acknowledges that they are fully aware present terms and conditions are accepted by entering information in WAREOS.

Any Member Association declares that it is entitled to enter a contractual relationship with the Local Organising Committee of the event, in accordance with these terms and conditions.

The Local Organising Committee commits itself to communicate, within reason, to its potential clients the greatest information available on the following topics:
Description of the main characteristics of the proposed products and of their use.

Pricing

Information on the methods of payment and reimbursement

conditions.

Article 1: Entirety

The platform <https://extranet.worldarchery.sport/wareos/> is the propriety of, has been designed and created and is managed by World Archery Federation at Lausanne, Switzerland, and put at the disposal of the Local Organising Committee to facilitate registration to World Archery events.

The present terms and conditions include any and all rights and obligations of the parties. No single, specific, or general term or condition that may appear on documentation sent, given, or handed over to a Member Association will alter, replace, or complete parts of or the entirety of these terms and conditions. World Archery reserves the right to modify at any time and without any preliminary notification of any kind these terms and conditions.

Article 2: Object

The present terms and conditions define the rights and obligations of the parties in relation to the registration made through the platform <https://extranet.worldarchery.sport/wareos/> of services offered by the Local Organising Committee in the scope of the event it has been set for.

Article 3: Contractual documents

The present terms and conditions and the registration process make up the contractual documents between the parties.

Article 4: Electronic signature:

The Member Association's entering registration information is the electronic signature which is binding between the parties in the same sense as a handwritten signature would be.

Article 5: Registration Confirmation – Contract

The contract is validated as soon as the Member Association has entered its preliminary registration by entering information in WAREOS. A modification of the registration is possible until the deadline for registration set in the document. Modifications may be subject to penalty fees.

Article 6: Prices

The official prices are listed in the “Policies and Procedures Athletes, officials and team management”, the invitation package prices will be based on the official price list, converted to the currency elected by the LOC for invoicing (CHF, EUR, or USD).

The official prices valid on the date that the registration confirmation is sent to the Member Association are binding

between the parties.

Article 7: Payment methods

All payments shall be made by bank transfer to the organising committee respecting the stated deadlines, with all bank charges paid by the Member Association. For any open invoices that are not settled 21 days prior the beginning of the event, the Local Organising committee will be entitled to charge a 5% surcharge on all open amounts.

Any payments received cash by World Archery on behalf of the organising committee will incur a 10% additional service fee, to be paid to World Archery.

Article 8: Payment deadlines and refunds

After the final deadlines of registration mentioned in this document, Member Association will not be entitled to any refund, and all remaining unpaid amounts shall be paid to the Local Organising Committee.

Failure to do so, will result in an immediate suspension of the Member Association, who will be set as not in good standing on the day of the official practice of the event, and so until the full amount is paid to the LOC.

Article 9: Availability of services

The availability of services is guaranteed on a first come, first serve basis, provided that the payment of such service has been paid to the local organising committee, partially or in full as mentioned in this document.

The local organising committee is not required to hold services for a Member Association that has not paid in full such service.

Article 10: Force-majeure

None of the two parties will have failed in their respective contractual obligations if their execution is delayed or prevented by a case of force-majeure. Cases considered to be a force majeure are extraordinary events or circumstances beyond the control of the parties, such as a war, strike, riot, crime, or an event described by the legal term "act of God" (e.g., flooding, earthquake, volcano eruption, etc). However, force majeure is not intended to excuse negligence or other malfeasance of a party, as where non-performance is caused by the usual and natural consequences of external forces, or where the intervening circumstances are specifically contemplated. The party experiencing a force majeure must notify in writing with 24 hours after becoming

aware of the occurrence. The parties will then, within 7 business days examine, unless the force majeure prevents it, if and how the contractual obligations will be met.

Article 11: Privacy statement

All information exchanged by the Parties will be treated with the utmost confidentiality. All information requested by World Archery and the Organising Committee from the Member Association are necessary to process the event registration and can therefore be communicated only to the contractual partners of World Archery and the Local Organising Committee.

World Archery and the Local Organising committee are authorized to send informative and promotional e-mails to the Member Association, using the WAREOS e-mail address and the contact person provided by the Member Association during the registration.
